

## **ELECTION PROGRAMME OF GOVERNING COUNCIL FOR THE TENURE 2015 – 2018**

The Elections of the Governing Council of **Agro Inputs Manufacturers Association of India** are scheduled to be held on 18<sup>th</sup> July, 2015 at 11.00 a.m. to 1.00 p.m. at Pune.

- 1) The list of the all members shall be published through e-mail on 11/06/2015 and the objections if any shall be entertained till 15/06/2015.
- 2) Nomination forms and election program shall be sent by general post service to eligible candidates.
- 3) The candidates desiring to contest the elections may send the nomination form by fill out required contents to the President/Secretary of Association through post service/by hand on following office address of Association **“Agro Inputs Manufacturers Association of India” “Shop No. 6, 1<sup>st</sup> floor, Madhyavarti Bhavan, Chhatrapati Shivaji Market Yard, Gultekadi, Pune. 411037,** before 30<sup>th</sup> June, 2015 till 05.00 P.M. The applications received after 30<sup>th</sup> June, 2015 shall not be considered.
- 4) The candidates should pay nomination form fees (*Rs. 100*) by depositing said amount in the Bank Account of Association or by paying in cash in the office of Association.

- 5) It is necessary to attach the said cash paid receipt along with applications. If any member failed to pay the form fees said member shall not be eligible for contesting elections.
- 6) Candidates shall also allow to submitting nomination forms and paying form fees by hand in the office of Association on above mentioned address before 30<sup>th</sup> June, 2015 till 05.00 P.M.
- 7) The eligible candidates means the candidates who are paid their membership fees from the date of enrollment as member of Association till for the year 2015. Moreover no any due is remaining towards the members. Such members have right to vote and contest the elections of Governing Council.
- 8) The nomination forms shall be scrutinized by the President/secretary or office bearer of the present Governing council in consultation with the President/Secretary and final list shall be prepared by the present Governing council before 06/07/2015.

- 9) If any candidate wants to take back nomination in that event he should file application to the president/Secretary of the Association and he should take back nomination before 9/07/2015 till 5.00 P.M.
- 10) The final list of eligible candidates shall be published on 10/07/2015 on the notice board of Association and the list of eligible members shall be sent by e-mail/general post to the all members.
- 11) The election shall be held for 7 posts of Governing Council. If nominations received more than 7 in that event elections will be held. If nominations received only 7 in that event said candidates shall be declared unanimously elected members of Governing council.
- 12) The Elections shall be held at 11.00 a.m. as has been scheduled.
- 13) The results of the elections shall be declared immediately.

**OTHER RULES FOR CONTESTING ELECTION OF GOVERNING COUNCIL  
FOR THE TENURE 2015 – 2018**

- 1) The candidate should be enrolled as member of the Association.
- 2) The candidates who are paid their membership fees from the date of enrollment as a member till the year 2015. Moreover no any due is remaining towards the members. Such members have right to vote and contest the elections of Governing Council for the tenure 2015-2018.
- 3) If membership is enrolled by the name of partnership firm/company in that event any one partner or director is allow to contest the elections on behalf of partnership firm/company.
- 4) If membership is enrolled by the name of partnership firm/company and one of the partner/director desires to contest the election then the candidate should submit consent letter or no objection certificate of other partners/directors along with nomination form.
- 5) If membership is enrolled by the name of company and one of the director desire to contest the election in that event the resolution of said company is necessary.
- 6) The presence of election contesting members is essential at the venue of election from start to end of procedure of election.
